SurvivorsUK is a national charity providing advice, information, emotional support and counselling to adults who identify as male who have been raped and/or sexually abused at any time in their lives and raises awareness about the issues.

This role enables us to supervise clinically our counsellors, provide extra individual counselling (including face to face, online and by telephone) support and organise groupwork as well as supporting generally the work of SurvivorsUK.

#### MAIN PURPOSE

Provide a combination of group and individual supervision to all sessional counsellors and groupwork facilitators at SurvivorsUK

# **KEY ROLES AND RESPONSIBILITIES**

- Maintain appropriate clinical records of all work and to report any concerns to the Client Services Director (CSD)
- Hold clinical responsibility for all client work for which supervision is provided
- Perform assessments for the counselling service and to maintain a regular caseload of counselling clients (including by telephone or online), as agreed with the CSD
- Plan, develop, co-ordinate and execute programmes of groupwork at SurvivorsUK in partnership with the CSD

- Support the CSD in the day-to-day running of the counselling and groupwork services, including being first point of contact should the CSD be unavailable or on leave
- Commitment to on-going supervision of supervision practice, attend regular supervision sessions with the CSD
- Work flexibly as part of a small team to provide maximum coverage for supervision, such as in the event of emergencies, and to attend team meetings as frequently as possible
- Represent SurvivorsUK to external agencies as required
- Undertake any other relevant and necessary tasks, as agreed with the CSD
- Abide by all SurvivorsUK policies and procedures
- Adhere to BACP Ethical Framework
